## Introduction

OptomCAS is the centralized application service for the schools and colleges of optometry. OptomCAS is a service of the Association of Schools and Colleges of Optometry (ASCO) and is administered by Liaison International, an education information technology company located in Watertown, MA. OptomCAS allows optometry applicants to use a single web-based application and one set of materials to apply to multiple schools and colleges of optometry. Applicants who apply through OptomCAS submit a completed web-based application comprised of biographical data, colleges and universities attended, academic course history, letters of recommendation, work experience, extracurricular activities, honors, and a personal essay. It is the applicant's responsibility to read and follow specific instructions for OptomCAS and the schools and colleges of optometry.

OptomCAS began its first year on July 15, 2009 for Admissions Cycle 2009-2010. Since its implementation, all eligible schools and colleges of optometry have participated in the centralized application service. OptomCAS provides validated numbers for the optometry application process.

This report will focus on OptomCAS Cycle 4, which is the Admissions Cycle 2012-2013. This OptomCAS cycle opened on July 1, 2012 and closed on June 2, 2013. The application fee was \$125 for one institution and \$45 for each additional institution.

## **Participating Institutions for 2012-2013**

As noted in Table 1, twenty one schools and colleges of optometry participated in OptomCAS in Admissions Cycle 2012-2013.

## **OptomCAS Trends**

### **Applicants and Applications**

The number of OptomCAS individual mailed applicants to the twenty one schools and colleges of optometry for 2012-2013 was 2,639. These applicants submitted a total of 13,210 applications for an average of 5.01 applications per applicant. See Table 2 below for a comparison to previous cycles.

There was a slight increase in the number of applicants for 2012-2013. The total mailed applications per applicant remained consistent at five applications per applicant.

## **Applicants by Offers per Applicant**

Of the 2,639 applicants who applied to OptomCAS with mailed application status, 1,856 (70%) received one or more offers of admission, while 783 (30%) receive no offers (reference Table 3).



## **Demographic Information on the Doctor of Optometry Applicant**

OptomCAS demographic data is captured on the OptomCAS application. This information is optional for the applicant to include and cannot be verified by Liaison staff.

#### Gender



As shown in Figure 1, females comprise of 67% (1,772) of the OptomCAS applicant pool with males at 33% (867). These figures remained comparable to the previous OptomCAS admissions cycle.

### Age



As shown in Figure 2, the majority of applicants were in the 20-25 age range. The average age for all applicants was 24 with a median age of 23. The youngest applicant was 19 and the oldest was 58. There was not a change from the previous OptomCAS admissions cycle regarding the average and median age.


### **Ethnicity**

As shown in Figure 3, the majority of applicants were White (51%) with the other applicants reporting Asian (29%); Two or More Races (7%); Black/African-American (5%); Spanish/Hispanic/Latino/Latina (3%); American Indian/Alaska Native (around 1%); and Native Hawaiian/Other Pacific Islander (less than 1%). Four percent of applicants did not report a race.



There was a very slight increase in Spanish/Hispanic/Latino/Latina and those who did not report a race in 2012-2013 according to Figure 4. There was a decrease in Asian applicants. There was no change for the other ethnicities.

### Citizenship

As shown in Figure 5, the majority of applicants for 2012-2013 were US citizens at 87%. Eleven percent of applicants reported they were foreign citizens and less than 3% US permanent residents. This was very similar to last year.

#### **State of Residence**

The top five states where OptomCAS applicants claimed their state of residence in 2012-2013 were: California, Texas, New York, Florida, and Illinois. There were 258 applicants from Canada. In the 2011-2012 Admissions Cycle, these were the same top five states with 224 applicants from Canada.

### **First Generation College Student**

For 2012-2013, over 63% of OptomCAS applicants had a parent who has attended/graduated from college, while 31% of applicants are first generation college students. Six percent of applicants declined to answer the question. This was not a substantial change from last year.

### **Military Experience**

Only 1% of OptomCAS applicants had previous military experience, which was the same as the last admissions cycle.

#### **Influences**

The top five influences on why an applicant chose to apply to a Doctor of Optometry program are: non-relative optometrist (46%); a parent who is a non-optometrist (13%); no answer (13%); relative optometrist (10%); and other health professional (6%). These influences were similar to last admissions cycle.

### **Academic Information on the Doctor of Optometry Applicant**

### **Major and Degree**

The most selected major on the OptomCAS application was Biology. Biology was also the top major last year. The majority of applicants have received or will have received their Bachelor's degree prior to enrollment (if accepted).

#### Institution

The University of California higher education system claims four of the top five spots for feeder institutions for OptomCAS applicants. These institutions are: University of California, Irvine, University of Houston, University of California, Los Angeles, University of California, San Diego, and University of California, Berkeley in the fifth spot. These are the same as last year.

#### **GPA**

OptomCAS calculates a standardized GPA to aid the schools and colleges of optometry in evaluating applicants using uniform and consistent criteria. The overall cumulative GPA for all applicants was 3.31 – for males it was 3.30 and 3.31 for females. The GPAs were similar in last admissions cycle where the GPA was 3.28 for males and 3.32 for females.

## **Accepted Profile of the Doctor of Optometry Applicant**

## Gender

For both Admissions Cycle 2012-2013 and 2011-2012, 67% of accepted applications were female and 33% were male.

### Age

The median age for accepted applications was 23 years old. Last admissions cycle, the median age was 22.8 years old.

### **Ethnicity**



As noted in Table 5, Asian and White had the highest rate of acceptance at 73% and 72%; followed by Spanish/Hispanic/Latino/Latina at 70%; American Indian/Alaska Native and Two or More Races at 64%; Native Hawaiian/Other Pacific Islander at 50% and Black/African-American at 46%.

As shown in Figure 7 below, Spanish/Hispanic/Latino/Latina, Asian, and Black/African-American increased their rate of acceptance.

## Citizenship

Eighty-seven percent of applications accepted were US citizens, 11% were foreign applications (this includes Canadian residents), and 2% were permanent residents of the US. In 2011-2012, the breakdown was very similar.

### **GPA**

The average GPA for accepted applications at the 21 schools and colleges ranged from 3.03 to 3.73.
